Prashant Srivastava on the said trust from out of his individual funds; and

WHEREAS the settler has deposited the said sum of Rs 11,000/- (Rupees Eleven
Thousand Only) to the Trust and has entrusted the trustees aforesaid with the
management and control absolutely of the said trust funds corpus; and WHEREAS the
settler aforesaid has settled the said sum of Rs11,000/- (Rupees Eleven Thousand Only)
on the said trust irrevocably; and

WHEREAS the trustees above named are willing to be invested with the ownership of the said money for the purpose of carrying out the object of the settlor the settler under directions set forth herein so as to enable the trustees to execute the objects of the trust, according to the directions and wishes of the settler.

Now, this deed of settlement in respect of the said charitable trust witness as follows:-

1. In pursuance of the said desire of the settlor, the settlor hereby settles and assigns unto the trustees the said sum of Rs11,000/- (Rupees Eleven Thousand-Only) to hold the same to the trustees upon trust and with and subject to the powers, provisions and agreements hereinafter declared and expressed.
2. The name of the trust shall be 'PADAM EDUCATION FOUNDATION and for the purpose of the management in carrying out all the objects of the trust it shall be situated at 20 VIKAS NAGAR KANPUR U.P. 208024 . The trustees shall have the power to change venues of the trust to such other place or places(s), as may be considered necessary and expedient by the trustees from time to time.
3. That the objects of the said charitable trust are as follows:-
 - (i) To establish and runs schools, colleges, Engineering college, Medical and Dental college, Law College, Vocational College , Banking Training Institute, Coaching Centre and other similar institute etc., for the advancement of the learning of the public in general and manage and help students by scholarships and prizes by rendering financial help for the purposes of their education;
 - (ii) To random financial assistance to educational and vocational institution imparting education for the benefit of the public as also to enable them to impart efficiency and economical up to date instructions to pupils and students in modern science, industrial vocation, research work, intellectual and use full pursuits;
 - (iii) To adopt means for development of a healthy as well as of a critical attitude to words the development of mental, physical and moral up lift of the students and all those connected with the educational institutions so as to make them good citizens.
 - (iv) To establish, maintain and run hostels, boarding houses etc. for students of any educational or vocational institution imparting education for the benefit of the public;

- (v) To construct Dharamshalas, old age homes and to maintain the same for the benefit and facility of the public and to start and run rest houses, public wells etc.
- (vi) To accept donations, grants, presents and other offerings and deal with the same for the purposes of the trust.
- (vii) To invest, dispose of, transfer and otherwise deal with the subject matter of the trust and/or its property/assets etc. in such manner as the trustees may think fit and proper in order to fulfill the object of trust effectively.
- (viii) To train and equip students so as to be self supporting to earn an honorable and decent way of life so as to develop into good, healthy and progressive citizens.
- (ix) To promote and inculcate the dignity of labors for appreciation of intellectual gift and talents of all kinds;
- (x) To encourage sportsmen organize sports events and to inculcate adventurous sprit in students community and those connected with educational institutions and to participate in games of skill powers.
- (xi) To develop disciplinary conduct and a habit to observe the rule of Law and self restraint in the students community in general as also in the public;
- (xii) To bring out encourage and develop the inventive and research facilities on the students and teachers in general and to afford opportunity for research work in Art, Science and industrial under taken;
- (xiii) To carry on any other objects of general public utility in the field of education, medicine and development of health;
- (xiv) To establish aid and/or run hospitals, dispensaries orphanages and such other charitable and humanitarian organizations and units, and
- (xv) To run any other institution, organization for the welfare of general public.
- (xvi) To do all the other acts, deeds and thinks for the purpose of carrying out the objects of the trust and for its proper management and working.
- (xvii) To borrow money from any person, Bank, Financial Institution or any other person for carrying on the object of the Trust.



trust which are the members of the Executive committee. There will be other designation of the Trust.

The Trustees will appoint the Office bearers amongst themselves. A person can hold two offices simultaneously. In case of Death or resignation of the Chairman or Secretary the trustee will nominate another person amongst themselves.

The Functions of the Chairman , Vice Chairman , Secretary and Finance Controller will be as under :-

- a. **Chairman**
- i) To convene all kinds of meeting and to preside the meeting as Chairman.
 - ii) To confirm the date for the meetings.
 - iii) To cast his deciding vote in case of any equal division of votes on any matter.
 - iv) To do all such acts which are necessary and beneficial for the Trust.
 - v) To sign Cheque jointly with Financial Controller and Secretary

- b. **Vice Chairman**
- (i) To Plan for Future activities
 - (ii) To Mobilise the Resources for expansion of the Trust
 - (iii) To Approve the Annual Budget for the Trust to be placed before the Executive committee.
 - (iv) To do all acts of the Chairman in his absence.

c. **Secretary** The Secretary will look after day to day work of the Trust. He will take policy matter decision in consultation with the Chairman and the Finance Controller. His work will include

- i.) To prepare agenda for meeting.
- ii.) To handle all kinds of correspondence on behalf of the Trust.
- iii) To obtain financial assistance for the Trust.
- iv) To Sign cheques on behalf of Trust jointly with Chairman and Financial Controller
- v) To execute all kinds of documents on behalf of the Trust.
- vi) To sign application on behalf of Trust to apply for any affiliation, empanelment with any authority Govt body. He may also authorize any other trustee to represent him
- vii) To enhance the image of the Trust amongst the public
- viii) To maintain the website of the Trust.

- d. **Joint Secretary**
- (i) To maintain the minutes of meeting of the Trust.
 - (ii) To look after the work of Secretary in absence of secretary.

e. **Trustee**

He will be In-charge for all the Financial Matters of the Trust, His work will include

- i) To maintain the accounts of the Trust

- ii) To keep the petty cash.
- iii) To Prepare and get the account audited as per Law.
- (iv) To Prepare the Annual Budget
- v) To attend Govt. offices, Income Tax, Trade Tax, Govt. department on behalf of Trust.
- vi) To Plan and Manage the Financial Planning of the Trust
- iii) To sign cheques jointly with Chairman and Secretary.

The Executive Committee may assign change any functions of the members or may designate any other function to any Trustee with unanimous consent. The trustee may form further rules and regulation to run the trust and amend the existing rules and regulations.

8. The trustees may out of the corpus of the trust funds spend such money or out of the sale proceeds of any part thereof, appropriate such money or part thereof for laying out, erecting and furnishing any building, research institute or for incurring any capital expenditure as may be decided by the trustees.

9. That the trustees shall be entitled to invest the funds of the trust not immediately required in securities, fixed deposits with banks or loans to private parties on such security or without security and on such terms as to interest and repayment etc. which the trustees at their discretion think fit and proper and can also raise loans/advances from banks/other financial institutions or private parties for its activities as and when required.

10. That it has been decided by the settlor that in case the Trust is unable to start any activity with in 5 years , the Trust may be winded up.

11. That the trustees shall maintain a banking account of the trust in any bank or banks as they may deem fit and expedient and shall also arrange to keep regular accounts of the assets and liabilities and income and expenditure and other affairs concerning the funds and properties of the trust. The operation of the Bank account will be as per the resolution passed by the Executive Committee.

12. That the Trustee may form a Management committee to run the Institution established by the Trust. The Managing committee will be appointed for such period as the Trustees deems fit. The Members of Managing Committee will be nominated by the Trustee. The members of the Management committee may be persons other than trustee. The Members of the Management Committee will be designated by various names and assigned various work. The members of the Managing committee will frame rules and regulations themselves to run the Managing committee and the Institutions. The Trustees will control and supervise the working of the Management committee and the Decision of the Trustee will override the decision of the Management Committee.

13. That the Trust is authorized to purchase the immovable property . The Trustees are authorized to sell, mortgage , pledge , lease , assign the trust property with unanimous consent.

14. That the Trust is authorized to borrow funds for fulfilling the trust objectives from Bank, Financial Institution, person, government organization with or without guarantee.

15. That the trust funds shall irrevocably vest in the trustees who will admit or/and spend the same in accordance with the terms of the deed.
